Sept. 1 is Key Date

The new ABX Air medical, dental and vision plans are effective September 1. Beginning on this date, all claims for medical, dental and vision services performed on or after September 1 should be submitted to the new ABX group numbers. The claim information for each claims payers is:

CAP/401(k)

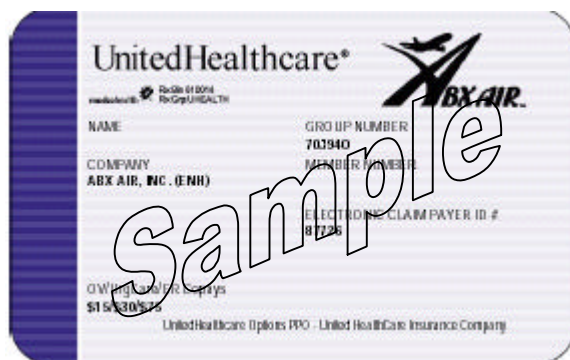
Transfer Complete

The transfer of assets from the Airborne Express CAP/401(k) plan to the new ABX Air CAP/401(k) plan was successfully completed on August 19.

The new ABX plan is now open for all services. You can check your account balance or make changes by contacting Fidelity Investments at www.401k.com or by calling (800) 835-5095.

The new ABX plan has all the same features and services as the Airborne Express plan. The same investment options are available except for the MIP II fund has been replaced with the MIP fund. (The ABX plan did not meet the minimal investment amount required for the MIP II fund.) More information about each fund is available from Fidelity Investments.

Disability Benefits

(Full-time employees)

ABX offers both short-term and long-term disability benefits for full-time employees. Eligibility is described in the benefits handbook. Starting August 15, disabilities that occur on or after this date will be filed under the new ABX plans. Disabilities that occur before August 15 will be filed under the Airborne plan.

If you have a disability or have upcoming surgery scheduled, your Benefits Coordinator will assist in getting the proper claim form filed and answering any questions you may have.

Questions & Answers

Q. I own Airborne stock purchased through the Employee Stock Purchase Plan. When will I receive my payment?

A. Payment from DHL can be expected within the next couple of weeks. For each share of Airborne stock you own you will receive \$21.25 plus one share of ABX Air stock.

Q. What is the trading symbol for ABX Air?

A. ABX Air trades on the over-the-counter bulletin boards under the symbol ABXA.

Q. How can I purchase ABX Air stock?

A. Any registered stockbroker should be able to assist you. ABX Air makes no recommendation about the value of its stock. At this time, purchasing through payroll deduction is not available.

Life Insurance & Accident Insurance

ABX offers the same coverage that was offered under the Airborne plan. Below are details about the transition of each benefit:

Life Insurance & AD&D (Full-time employees)

For full-time employees, ABX provides Life Insurance and Accidental Death and Dismemberment (AD&D) coverage in the amount of 1½ times your base annual salary (up to the plan limits). This is the same coverage provided under the Airborne plan. No action is required by employees for this coverage as the coverage is automatically in place. Your beneficiaries will remain the same.

Universal Life Insurance

ABX offers an optional Universal Life insurance coverage for all full-time and part-time employees. Employees enrolled under the Airborne plan will automatically continue their coverage under the ABX plan at the same rates. If you were not enrolled in the Airborne plan, you may enroll by calling the plan administrator Marsh@Work at (800)447-9381. You will be subject to evidence of good health before enrolling in the plan.

Voluntary Accident Insurance

ABX offers an optional Voluntary Accident insurance coverage for all full-time and part-time employees. Employees enrolled under the Airborne plan will automatically continue their coverage under the ABX plan at the same rates. If you are not currently enrolled in this plan, you may do so during the next open enrollment period scheduled for November.
