# CAP/401(k) company match 48¢ for 2007

ABX Air is pleased to announce that the total CAP/401(k) matching fund amount for 2007 is 48¢. Under our CAP/401(k) plan, ABX Air contributes the base match of 35¢ on the first six percent of eligible contributions to the 401(k) each payroll period. At the end of the year, ABX Air reviews its financial performance under the Aircraft, Crew, Maintenance and Insurance (ACMI) and Hub Services agreements with DHL to determine if any additional performance match is due.

On March 17, 2008, the company announced its fourth quarter and year-end results. These results showed that the company received a 1.25 percent incentive markup from DHL ACMI and Hub Services agreements for 2007. As shown in the Snapshot graph below, the additional performance match is 13¢ for a total of 48¢ in 2007.

"When I arrived at ABX Air last year, I was immediately impressed with the teamwork, efforts and attitudes of the employees," said John Graber, President of ABX Air. "This incentive match is one of the ways we directly reward employees for the outstanding service we provided to our customer, DHL."



# Questions & answers

# Q. When will the performance match be deposited in my CAP/401(k) account?

A. The Company expects the performance match to be deposited into your account by April 30, 2008. The amount contributed is based on your 2007 contributions to the plan. Because the company has already contributed the 35¢ base match each payday during 2007, the amount contributed for the performance match is 13¢ up to the first six percent of pay contributed to the plan.

### Q. How will the performance match be invested?

A. The performance match will be invested according to your current fund elections using the same investment split as your current payroll deductions. If you would like to make a change to your current elections, you can do so on-line at www.401k.com or by calling Fidelity at (800) 835-5095.

# 401(k) enrollment

Are you taking advantage of the free money being offered to you? If you are not participating in the 401(k) account, then you are missing out on possibly hundreds or even thousands of dollars each year.

Now is a good time for all employees to review their 401(k) deferral to make sure they are maximizing the company match by contributing at least six percent of their pay to their 401(k). To enroll in the company 401(k) plan, change your deferral amount, obtain rollover forms, or get more information, go on-line to www.401k.com or call Fidelity at 1 (800) 835-5095.

If you are new to the company or newly eligible for the plan, you will have an enrollment kit from Fidelity mailed to your home. New part-time or full-time employees are eligible to start contributing on their 61st day after hire. However, you do not have to wait until your 61st day to roll eligible money in from another qualified retirement plan.

### Pharmacy grand opening and ribbon cutting

ABX Air celebrated the official grand opening of the new ABX Air Pharmacy on Monday Feb. 18, 2008. The pharmacy, operated by Walgreens, is adjacent to the ABX Air Healthcare Center and offers customized services to ABX Air employees and their families. In addition to

filling prescriptions prescribed by physicians at the ABX Air Healthcare Center, the pharmacy also can fill prescriptions from physicians in the community.

The on-site pharmacy offers a \$4 copay for all generic medications on the ABX Air benefit plan.

It is open from 7 a.m. to 8 p.m. Tuesday through Friday, and from noon to 8 p.m. on Monday. Call (937) 382-1079 to refill a prescription or for help with any of your pharmacy needs.
